

### **Sibling Discount:**

Families with more than one NBYSL/AC MARIN player will receive a discount on NBYSL AND AC MARIN Club Fees. A 10% discount for the second sibling and a 15% discount for the third sibling. The discount will be applied to the last club payment fee.

### **Delinquent Payment Policy**

- Players whose club payments are not current will not be issued a player card.
- If financial constraints make a missed payment possible, alternate arrangements must be made with the club accountant at [info@northbayysl.com](mailto:info@northbayysl.com)
- Families that owe the team or club money at the end of the season will be referred to a collection agency.

### **Financial Assistance**

The club includes an amount in its price to fund financial aid for those who demonstrate a need via an application. After a player has been picked to join a team, an application for financial aid might be obtained. The application must be accompanied by the necessary documentation. If awarded, players pay reduced club fees, and an award is calculated as a percentage of the player's estimated club fees. It is expected that any family receiving financial aid will do volunteer hours for the club and/or take on a club role. The maximum award granted is 50% of club fees for the most deserving. **The financial aid must be returned if a player leaves his or her team before the end of the season. Meaning you will be charged the entire year at full cost.**

### **Playing Time**

AC Marin is a competitive club. We do our best to make sure every player has a great experience but playing time is not likely going to be equal for all players. AC Marin policy does not guarantee a specified amount of playing time for the competitive team player during league or tournament play.

## Parent Financial Contract

As a parent, I commit to the following:

1. As the responsible party, I agree to make all payments to fulfill our financial obligation before or by the due dates listed. This includes fees for both the team and the club.
2. I understand that my commitment is for the entire 23/24 ending May 31, 2024. Season and that I am obligated to pay all NBYSL AND AC MARIN fees/costs. I understand that if my child departs or leaves the team for any reason other than a season-ending injury, I will continue to be responsible for all NBYSL AND AC MARIN fees/costs until May 31, 2024. The parent/player is not eligible for a refund. In addition, I will pay a \$300 inconvenience fee to my team. My child will not be permitted to participate in future tryouts or team selections with NBYSL AND AC MARIN or any other local organization until all outstanding balances are paid. If a member is delinquent on payments, their player's pass will be revoked and they will be placed "Not in good standing," preventing them from participating in any NBYSL AND AC MARIN event until their account is "In good standing" Please contact us if you are experiencing financial difficulties; we are willing to assist if we can. Any account in arrears is referred to a collection agency for resolution, and an administrative fee will be applied to the outstanding balance to cover collection agency expenses.
3. I will share in any additional team expenses, which include but are not limited to; tournaments, leagues, referees, team equipment, coaches' expenses, etc. above and beyond the club fee, uniform fee, and team events fee should they arise. I understand that if I have a team fee that is 30 days past due, I will be removed from TeamSnap and a \$30 late fee will be applied.
4. I understand that if I am accepted into a financial assistance program, that makes me responsible for volunteering time to help support the club-sponsored events. I also understand that if I accept financial aid and leave the team early, I am responsible for paying the rest of the season at full cost.
5. My child is a teammate. If I skip a game or competition without 24 hours notice to the coach, I agree to pay my team \$50.00 for the first offense, \$100.00 for the second offense, and so on. After 4 missing competitions without notice, I accept I may be asked to leave the team without a refund (injury and emergency excluded).
6. I am aware that I must receive permission from my coach and the Director of Coaching (DOC) before guest playing or participating with another team/club. This includes Futsal, Indoor Soccer, Ligan Deleon, Boliche League, among others. If discovered, I agree to pay my team a fine of \$50.00 for the first offense, \$100.00 for the second offense, and \$200.00 for each subsequent offense.
7. I am aware that, as a parent, I cannot enroll a team in non-AC Marin-sanctioned leagues, tournaments, or games without written permission from the DOC. I agree to pay a \$300 fine if discovered.

## **Player Code of Conduct Contract**

As a player of NBYSL AND AC MARIN and AC Marin, I commit to the following:

1. I will train and compete to the best of my potential.
2. Possess a positive attitude and do whatever is asked of me on the soccer field, without complaining, for the good of the team.
3. Win without bragging and exemplify good sportsmanship.
4. Respect the officials and accept their decisions without question.
5. Encourage and never criticize my teammates.
6. Learn and abide by the game's rules. We encourage all participants over the age of 13 to enroll in a referee course.
7. Respect my coach, teammates, and my opponents.
8. Arrange my schedule so that I can participate in all practices, scrimmages, games, tournaments, and team events on time. Failure to participate in practices or tournaments will place the player in jeopardy of losing playing time or being cut from the team. This is a commitment you make to your team to be present for all scheduled team practices and tournaments.
9. Notify my coach or team manager via Teamsnap if I will be late or unable to attend a practice or game with ample notice. I acknowledge that it is the primary responsibility of the participant, not the parent, to notify the coach of any absence – prior to the absence. We require at least two hours' notice before any missed practice.
10. Attend practices and games properly dressed according to club and team standards. Players who do not wear the appropriate training uniform to practice (gray training shirt, black shorts, and black socks) will sit out.
11. Arrive on time, well-rested, hydrated, and with a positive attitude to every game and practice.
12. Give my coach, trainers, etc. my complete focus during training and at games.
13. I will abide by the rules, policies, and procedures of NBYSL AND AC MARIN.
14. I understand that since this is a premier competitive environment, there is NO Guarantee of minimum playing time, position, or placement on a team, but it is dependent upon my efforts, commitment, and skill.

*EVERYTHING YOU DO IN PRACTICE OR A GAME AFFECTS NOT ONLY YOU BUT THE WHOLE TEAM. WHETHER YOU PLAY A LOT OR A LITTLE, PLAY YOUR BEST. ALL PLAYERS ARE VERY IMPORTANT TO THE TEAM. WE WIN AND LOSE TOGETHER AS A TEAM.*

If you are willing to make this commitment, we believe we can assist you in becoming a stronger soccer player and a valuable contributor to a successful and competitive soccer program.

## Parental Code of Conduct Agreement

- I will promote sportsmanship by always showing support for all players, coaches, game officials, and administrators.
- **I will never instruct from the sidelines and will always allow the coach to be the sole coach.**
- I will not criticize the coach.
- I will place the emotional and physical well-being of all players ahead of my desire to win.
- I will always promote sportsmanship among my fellow NBYSL AND AC MARIN parents, instructors, officials, and players.
- I will always remember that soccer is an opportunity to learn, have fun and remember that the game is for the players, not for the parents.
- I will do the best I can each day to remember that all players have talents and weaknesses the same as my child does.
- I will treat the coaches, other players, game officials, other administrators, and fans with respect at all times, regardless of race, creed, or ability, and I will expect the same in return.
- I will support the coaches, officials, and administrators working with my child in order to promote a positive and enjoyable experience for all.
- I will not access the playing field or coaches' bench for any reason unless requested by the coach or official.
- I will not criticize game officials or submit complaints against them on my own initiative. If a complaint is warranted, the Club President shall present and make it.
- **Parents and spectators are prohibited from making comments to the referee(s) or advising the referee(s) to keep an eye on certain players or deal with violent play. Parents and spectators are prohibited from yelling at the referee(s), including criticism, derision, harassment, intimidation, or any other type of feedback, before, during, or after the game. Any parent or fan of AC Marin who receives a red card will be fined \$200 and suspended for five matches. The \$200 will be paid to the team, not the club. The team manager, coach or club may inflict this fine upon a spectator. Spectator has 10 days to pay this fine or a \$50 late fee will be applied.**
- If I have a complaint or concern, I will not approach the coach directly after the game or in front of the other players. I agree to wait at least 24 hours following the conclusion of the competition before approaching the coach when he or she is not in the presence of other participants.

Failure to comply may result in the suspension of your privilege to participate in sanctioned events or any event in which NBYSL AND AC MARIN is being represented.
